





It was with honor Jodi Ann and I represented members ofConnecticut State Grange at our National Grange Convention in Tulsa, OK November 5th through the 13th. The session started with a 5.6 magnitude earthquake that shook the 11 floor hotel. Fortunately there was no damage to the hotel.

Jodi Ann served Taxation the and Transportation and I served as Chair for the Grange Law Committee. Serving as a Session Chair was truly a learning experience, I now understand the importance writing properly resolutions, therefore I have encouraged our Legislative Committee to hold at least two workshops, one in the east and one in the west, to address this important issue and help develop better leaders through the resolution process.

The Delegate body of this State Grange voted to send 6 resolutions to National for consideration. Resolution # 2, 3, 13, 17, 25 and 31. Resolution #2 and 3 where written into the Grange Growth and Development's Policy Statement, # 13 and 31 were adopted by the Delegate Body and #17 was withdrawn by me. Please refer to either your session's booklet or last month's

these resolutions.

Ed Luttrell was again elected National Master and our own F. Phillip Prelli was re-elected to the National Grange Board of Director and remains its Secretary. Priest Archon Dan Bascom Installed the Officers of the National Grange using the revised Installation Ceremony and did a very nice job.

I stated in my President's Address to this State Grange, I oppose and do not support the use of this revised ceremony in Connecticut. After seeing this revised version, I FIRMLY stand by my statement. One resolution presented to the Grange Law Committee was to do away with the Passwords in their entirety as it is being used less and less Nationwide, this was defeated. We protect our password that is optional but we allow the beautiful lessons of our Installation to be altered and not for the better in my opinion. What's next, the 6th Degree? How about the 7th?

This revised version took 40 minutes. A full Installation takes just around one hour. Otherthan the minimal time savings, I did not see how changing the words improved the beautiful lessons, again my opinion. I am puzzled as to why the Delegates to the National Grange felt this necessary.

Don't misunderstand my intentions here, we do need to continually review our policies and procedures, I am all for progress, I am all for growth. We as leaders, at all levels, need to stop

Granger for the details on taking the easy road by cutting programs departments. We need to think progressively, think ahead to the impact and footprint we are leaving for those yet to come. Let's stop thinking backwards, when we are faced with

these challenges, let's brainstorm on how we save these programs, with changes, rather than cut. As we continue to cut programming at any level, we are making hard to secure new members.

I will be working with our State grange Executive Committee and Directors to find ways to GROW our

present programming and participation. We have an amazing story to tell everyone, it is each of our responsibility to continue to write that story by challenging ourselves, our leaders and membership to think "out of the box" and ask you how we can grow. I ask each of you, how can we help?

A sounding board for local issues



We had 51 resolutions submitted by the Granges or committees at this last State Grange session. This is more that we have seen in quite some time. These resolutions covered many topics from Grange related to community and state related issues.

This last year the state budget was a hot topic and this was reflected in the resolutions. The delegates voted to support saving the two historic ferries that cross Connecticut River in Rocky Glastonbury. Hill and They also voted to support continuation of the Connecticut Technical Schools and to continue to support the Connecticut Agricultural Experiment Station that was threatened in the last budget. The delegates discussed the sales of invasive species of plants in the state and some safety issues such as the blocking of handicapped entrances and walk times

in crosswalks.

In response to tropical storm Irene, the delegates voted to encourage the state to work with utility companies to better prepare for future emergencies. It was noted that some towns were without emergency 911 services during the power outages of Irene. This was also apparent the outages that happened after the October snowstorm.

The delegates voted to allow North Central Pomona to merge with East Central Pomona. The delegates also approved a state dues increase. There were many resolutions on Grange processes so the delegates decided to look into revising State Grange There was a by-laws. resolution to allow Granges select alternative delegates to State Grange and another to allow use of the Obligation Ceremony. Both of these resolutions were adopted.

Grangers should also be aware of local issues their communities. Many towns just held local elections. The news reported that turnouts were very poor. There were many towns that could not get enough people interested in local positions so that many candidates

had no competition. one town there were two budget related questions on the ballot. Both of the questions passed, but due to the low voter turnout, both items failed because of the percentage of town voters were not high enough to be a legal vote. Local elections just as important state and national elections. Local officials are the ones that directly affect your pocketbook. They set tax rates and determine budgets. They decide if schools can have a new roof or fire departments can get some new equipment. Your local boards have a say in the development in your towns through your zoning which could assist with tax revenue.

Your Grange can become a sounding board for local issues. Talk about what is happening in your towns at your meetings. Invite town officials to speak on local projects and invite the public in to meet with the local officials and hear about the projects. Encourage all to vote. Not just for the "big ones", but also for your local elections and budget votes. Grange roots have always been deeply involved in political issues.

Important National Digest Change

November 20, 2011

Patrons,

There was action taken by the delegates at National Grange that each Community Grange must be aware of.

There is a change in article 6.2.4 Code of Subordinate Granges, it was amended to read: 6.2.4 Whenever the membership of a Subordinate Grange declines to fewer than 13 members or fewer than four members of either gender, the Charter shall be suspended or revoked pursuant to article V of the By-Laws of the National Grange.

This change was immediate and is in effect. It is important your Grange review your membership records to make sure you are in compliance with 6.2.4 as written above. If you are in violation, it is imperative you contact me as soon as possible so we may discuss and develop action plans to stabilize your membership.





Conn. Farmland Trust Seeks Accreditation

The Land Trust Accreditation
Commission is now accepting
public comment on the Connecticut
Farmland Trust's (CFT)
application for Accreditation.
With an office in Hartford, CFT
is Connecticut's only statewide land

is Connecticut's only statewide land trust and the only land trust dedicated to the protection of agricultural lands.

"Achieving Accreditation will show our partners and potential supporters that we meet national standards for protecting land and will make us one of only five Accredited land trusts in the state - and the only one with a statewide focus," says Jim Gooch, Executive Director of the Connecticut Farmland Trust. "CFT is a very efficient and effective organization. For every dollar raised, we leverage 34 dollars in conservation and our administrative costs are only 13% of our budget. But having the wherewithal to steward this land and keep our promises forever means more than being good right now - it requires a strong foundation built on best practices."

"CFT's task is especially challenging," notes Gooch. "We protect the land to ensure it will always be used for farming. People need to be able to do 'stuff' - till, plant, fertilize, harvest, sometimes even build - while at

the same time we need to make sure the best soil is always protected. And not just for today's farmer or tomorrow's, but for the sake of the food we'll need 100 years from now."

There are over 120 land trusts in Connecticut; only four of them - all with a local focus - have attained accreditation. The Commission is accepting public input until from now until January 2, 2012 on how CFT complies with its national quality standards, which can be seen at www. LandTrustAccreditation.org. GLEANINGS FROM YOUR STATE PUBLIC RELATIONS TEAM

The Public Relations committee is offering a total of seven contests this year. There have been a few changes to the six contests from last year to hopefully make them more appealing for Granges to participate. We also added a brand new contest as well. Let's take a quick peek at each one.

- 1) "Spot On" 60-Second Grange Video Commercial Contest: Think of an idea for a commercial representing your Grange. Make us laugh. Make us cry. Make us say, "Wow! I want to join the Grange." Make it something you'd want to see on TV. You write it. You cast it. You direct and shoot it. You have total creative control. For 2011-12, the Commercial time has been extended to sixty (60) seconds in length, including any tags. Also, entries must reflect either the theme "Community Grown" or "Create, Win, Grow."
- 2) "Spreading the Word" Connecticut State Grange Website Participation Contest: Spread the Word about your Grange, its projects, activities and events by submitting content to the Connecticut State Grange website. Submissions can be articles, photos, calendar events and scrapbook items (such as newspaper clippings and historical data). Submission period runs from November 1, 2011 October 1, 2012.
- 3) "Show Us Your Stuff" Grange Marketing Contest: One of the best ways for the Grange to reach the community is to spread the Grange name. Show us a collection of the ways that your Grange promotes itself in the community through its marketing efforts. The possibilities are endless. Some examples include:
 - Hosting and then publicizing an Agricultural Fair
 - Community Displays and Booths at local non-Grange sponsored community events
 - Signage in your community
 - Participation in internet activities such as having an individual Grange Website and Social Media such as Facebook and Twitter
 - and more!

To enter, submit a report of NO MORE than 12 pages containing a description and photos/scans on how your Grange promotes itself through marketing. Note that this contest is not a community service contest, although it incorporates community service fundamentals. Entries should concentrate on the promotional aspects of the projects your Grange participates in.

4) "Convey the Message" - Best Grange-written Press Release Contest: An engaging press release with an interesting 'hook' or angle is an excellent way to gain exposure for your Grange and can lead to publication in newspapers, magazines and on the internet. Show us how your Grange uses Press Releases to capture an audience. Entries must be an ACTUAL press release written and used by your Grange, should be less than 500 words in length, and follow the proper style and format as described in the Connecticut State Grange Public Relations Tool-Kit booklets.

- 5) "Let's Advertise" Best Grange Event Poster: Set your imagination lose! Let your mind run wild, but be sure that your artwork relates to your Grange event. Submissions must be an ACTUAL poster designed, executed, and used by your Grange for an event. Posters should be a minimum of 8.5 x 11 in size (no limit on maximum size), and may be in either black and white, or color, and can be computer designed or hand-drawn.
- 6) "In the News" Best Newspaper Article Contest: Research has revealed that the news media is responsible for influencing the thoughts and behavior of the general public. Here's an opportunity to show how the Media has helped promote your Grange through the written word. Entries must be an ACTUAL printed or published newspaper article written about your Grange.
- 7) "Creating a Buzz" Connecticut State Grange Social Media Participation Contest: New for 2011-2012. Create a Buzz about your Grange, its projects, activities and events by setting up a proper Facebook or Twitter Page and then managing its contents. This contest is open to all Community Granges, Pomona Granges and Junior Granges. Pages must be active at any point within the period of November 1, 2011 - October 1, 2012. Pages must be set-up according to the guidelines specified by the Connecticut State Grange, and be in compliance with the Terms of Service of Facebook and/or Twitter.

All of the details, rules, and information for the contests can be found on the Connecticut State Grange website at www.CTStateGrange.org, and are also available in the BlueBook. The deadline for all of the Public Relations contests is October 1st. 
