To say that growing membership for the Grange is a challenge on a normal year is an understatement. To grow membership without meetings, in house events or community service during 2020 feels nearly impossible. You may have realized though, I don't give up easily and with creative thinking and collaboration we can get through this successfully.

When I spoke to the Board in February about coming on full-time. I planned to visit as many Granges as possible to create specific membership development plans, along with a few big educational events. The event to kick it off was to be presented by a professional speaker on leadership and Membership Growth. The basis of the plan was in-person events. Within a week of accepting the position in March, the

This Spring when the pandemic hit, the State Grange made changes and took action to best serve our members and our communities. We quickly made a shift with meetings going virtual, events cancelled or changed to drop off and pick up and now, right here, the biggest and largest event we have yet held virtually, the 136th Session of the Connecticut State Grange.

I do not make light on the financial stresses of this time but there is a positive quality of life that has returned to some households. Maybe this is the slow down we need as an

organization to see clearly what our towns and cities need to feel supported by the Grange so we may serve them better. This is a meeting point between the past and the future and we are getting a chance to shape how we fit into that future and continue to be relevant.

We have become dependent on in-person events as the source of revenue and membership growth. We have not been able to include the busy families or the sick and

the physically challenged people in our meetings. Because of virtual meetings they have a much better opportunity to participate. For some Grangers their children and younger relatives are assisting to get them online. This helps tie us together in a shared experience.

Seven months ago I was absolutely guilty of not stretching to see what was possible virtually for us to develop new members. I was caught between knowing what used to work and having a dream of bringing the Granges back from the brink of extinction. Made clear by the fact that I presented my platform for employment for the State Grange on this very thinking. Events will always be a valuable piece of the membership community-building puzzle. We must expand our ideas and evolve with this new but hopefully temporary new world.

Though we have had a rough start and needed time to adjust to the changes, we quickly refocused to serve the current membership and the Board took quick action to make a Zoom account available for Granges to meet virtually. We solved the Logistical Issue of how to have a meeting.

Many Granges have used this Zoom account plus there are many who have used their own account, or they made phone calls or sent emails to keep in touch. Some Granges have really moved out of their comfort level and have made attempts to meet virtually even with limited computer users.

On the National level, National Membership Director, Joe Stephenoni, has offered membership meetings open to everyone over the past few weeks. He is teaching and offering open discussions to help Granges to problem solve during these tough times. I was able to attend one in September and found the group brain-storming helpful. He and I also chatted again to discuss what he is working on and the plans for the next year. Of course this is where public health and

safety guidelines allow.

As you may remember, at the 2019 state session, a resolution regarding Virtual Granges was passed as a tool to grow participation by younger generations. When speaking to Joe he explained he has found these types of Granges to be challenging. We will continue to discover and explore the best approach and though it seems much more in reach going forward.

We chatted about the benefits of membership, tangible and intangible. Based on that discussion I will be creating materials with all the benefits of membership that will be updated and distributed to Granges as a Membership growth tool. I will also be seeking to add more benefits that are specifically relevant to Connecticut.

The National Membership Director said he has suggested we offer our halls, where possible, to help schools and other community organizations that can not meet in their own spaces due to size and number of people regulations. There are schools that allow clubs to meet but not on school grounds. This free offer will get new people into our halls and be of service.


Another share of halls is happening in California where they are setting up 2 different Granges with different charters who share the same building. These Granges have different focus but with this arrangement the hall is supported and members can join depending on their interest. This is an idea I will approach the Executive Board about in the next few weeks.

When thinking to the future we will be experimenting with things that have been working for other Granges around the country plus businesses and organizations who have managed to grow and thrive these past several months.

Interestingly, the key word that came up in the conversation with Joe was Logistics. Our challenges across the table for the next year will be LOGISTICS. So much so that our first thought with every meeting, event or fundraising idea

Resolutions Adopted at the 136th Annual Session

1) STATE COMMITTEES

THEREFORE BE IT RESOLVED

that Article IX COMMITTEES be changed to read:

Section 6. The wording "A Committee of Women's Activities of five, shall be appointed by the State Master" be changed to read "There shall be a Committee of Family Activities of (at least 3 members but) no more than 5 members appointed by the State Master"; and

The following wording "of five members" in Section 7, Section 8, and Section 10 be changed to read "of (at least 3 members but) no more than 5 members", and

THEREFORE BE IT RESOLVED:

Section 11 be changed to read: "There shall be a Membership Committee consisting of (at least 3 members but) no more than five members consisting of a minimum of one member from each Pomona Grange to be appointed by the State Master, and

2) RE: EMERGENCY EXECUTIVE POWERS

THEREFORE BE IT RESOLVED

that the Connecticut State Grange, through its Legislative Committee, urge the passage of legislation to modify the Emergency Powers Act to limit the length of time of the act to 3 months unless the Legislature meets again to extend the time after the 3 month period.

3) RE: SALE OF GRANGE PROPERTY

THEREFORE BE IT RESOLVED that the first sentence of Sec. 4.11.1(G) be changed to read:

"When a sale of real property is concluded, the selling Subordinate or Pomona Grange shall account for the net proceeds of the sale received at the time of settlement and shall remit all but the sum of \$1,000 \$10,000 of such net proceeds or the net proceeds whichever is less to the State Grange having jurisdiction to be held in trust escrow for the said Subordi-

nate or Pomona Grange."

4) RE: UTILITY RATE INCREASES THEREFORE BE IT RESOLVED

the Connecticut State Grange encourage the Connecticut General Assembly to never pass legislation that allows for an increase in utility charges, either for generation or delivery, that exceeds 10% of the standard cost of living for that given year, and

BE IT FURTHER RESOLVED the Connecticut State Grange present informational programs educating communities it serves on its options for utilities available to them in Connecticut.

5) RE: DEVELOPMENT RIGHTS

RESOLVED the development rights to all farm and forest lands covered by Connecticut Public Act 490, be eligible for purchase by the State of Connecticut Department of Agriculture.

REFERRED TO THE STATE LEGISLATIVE COMMITTEE FOR REPORT AT NEXT ANNUAL SESSION.

7) RE: SUPPORT LOCAL FARMS

THEREFORE BE IT RESOLVED

that the current \$2 for \$1 SNAP ben-

efit program offered at farmers' markets be extended year-round for CT Grown products as a voluntary participation program for any vendor.

8) RE: OLD AND OLD GROWTH FORESTS

THEREFORE BE IT RESOLVED

that old growth forests and remnants on public land be strongly protected and provide a buffer, and older forests be protected to maximize their ability to store carbon and protect biodiversity and become old growth forests in the future.

9) PROCESSING PLANTS

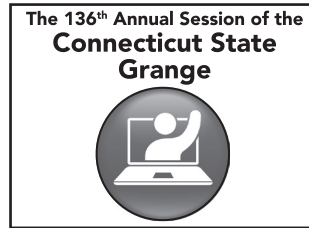
RESOLVED

that the CT State Grange support the development of more meat and milk processing plants in CT and that we through our State Legislative Committee urge the State Department of Agriculture to investigate and implement this issue.

10) RE: MASTER'S ADDRESS

THEREFORE BE IT RESOLVED

the Connecticut State Grange thank the State Master for his service to the Connecticut State Grange during the preceding year and commend him for his fine report and leadership.

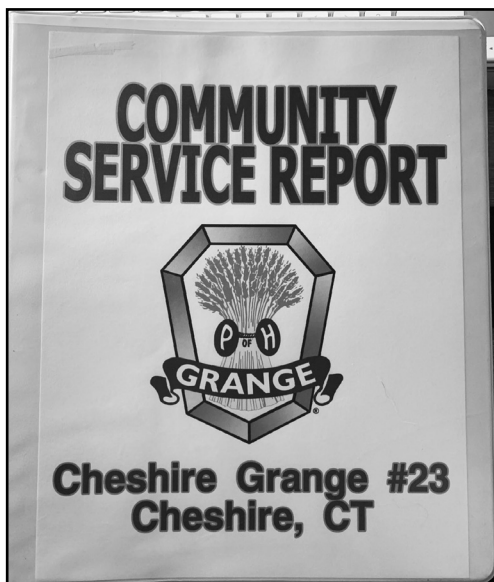

2020 in Review and Looking Ahead to 2021

2020 has definitely been a time of evolution for the Grange - not only in how we gather, how we host activities, entertain and congregate, but also in our habits and needs. Platforms like the various types of Social Media (Facebook, Twitter, Instagram, etc.) have become more than just fun but a vehicle of information, and software like Zoom has become a new normal, allowing us to connect digitally and virtually in ways never before thought about in Grange circles.

The Connecticut State Grange Public Relations Committee has adjusted our strategies and our programs to incorporate the new normal and reflect the changing public relations trends taking the forefront this year.

We decided to disregard our contests, as Granges were unable to host events and connect in ways that worked within the contest guidelines. For 2021 and looking forward, we will be developing a robust new program that is more suited to digital and virtual connections. Keep an eye on the CT Granger as we will be announcing this in an upcoming issue.

PR Co-Director Robert Charbonneau has been keeping the website current by updating it monthly with all of the articles from the CT Granger, as well as other articles as needed. This is a huge undertaking each month, and we thank him for all of his hard work.

We continue to utilize our strong Social Media base including Facebook, Twitter, YouTube, Pinterest, and more. In 2020, we added Instagram to our Social

Media portfolio. Facebook is changing how its platform works for businesses and organizations, so we have no choice but to adjust moving forward. In February 2021, we will host a webinar with the Membership Committee to teach our Granges how to best utilize the new Facebook tools for their Granges.

In late May, we started an e-mail newsletter for our membership that has been sent out on a regular basis. We continue to add to our mailing list in hopes of getting information out to the majority of our members.

In conjunction with the Membership Committee, we offered training services to our members for the Zoom platform, and held a number of one-on-one sessions to help get them used to the software and its workings. We also set-up a series of 6 Social Hours held weekly on Thursday evenings in September and October prior to State Session to give our members a chance to work with the Zoom software and feel comfortable using it. These gatherings each had a small program as part of the evening, such as trivia, guess the Grange Hall, etc. Attendance at

the Social Hours grew each week, with our most popular evening having 29 people in the Room. These will continue at minimum monthly moving forward, to allow our members to connect virtually.

Studies show that in 2020, audiences generally prefer simplicity, convenience and transparency. Our Granges are no different. We encourage Granges to be authentic, personable, relatable and even casual to a degree when looking ahead, and to remember that our audiences are comprised of more than the organization in which they share, but of the people who are dedicated to the organization. We need to always be considerate of our members' time and be respectful of what's on their minds and of the ideas that they share.

The habits of our members and supporters are changing at an unprecedented pace, while 2020 has forced us as an organization to adapt to these changes, and to see first hand the shift before us. We must focus on our fundamentals and revamp our message to tie back to our foundations in the long term.

Getting the word out to the public about our Granges, their projects and activities makes a difference. Just ask the Granges who have utilized our services and resources and have seen positive results. We are here to serve every Grange and Committee at all levels - all you have to do is ask!

The Best Chicken & Dumplings



Homemade Chicken and Dumplings are a traditional fall comfort food - and as the weather gets chillier, it's the perfect dish to bring you back to childhood days. This recipe from Taste of Home is quick and easy!

INGREDIENTS:

3/4 cup all-purpose flour, divided
1/2 teaspoon freshly ground pepper
2 tablespoons canola oil
2 medium carrots, chopped
3 garlic cloves, minced
1/2 cup white wine or apple cider
2 bay leaves

DUMPLINGS:

1-1/3 cups all-purpose flour
3/4 teaspoon salt
1 tablespoon butter, melted

SOUP:

1/2 cup heavy whipping cream
2 teaspoons minced fresh thyme

INSTRUCTIONS:

In a shallow bowl, mix 1/2 cup flour, salt and pepper. Add chicken, 1 piece at a time, and toss to coat; shake off excess. In a 6-qt. stockpot, heat oil over medium-high heat. Brown chicken in batches on all sides; remove from pan.

Add onion, carrots and celery to same pan; cook and stir 6-8 minutes or until onion is tender. Add garlic; cook and stir 1 minute longer. Stir in 1/4 cup flour until blended. Gradually add stock, stirring constantly. Stir in wine, sugar, bay leaves and peppercorns. Return chicken to pan; bring to a boil. Reduce heat; simmer, covered, 20-25 minutes or until chicken juices run clear.

For dumplings, in a bowl, whisk flour, baking powder and salt. In another bowl, whisk milk and melted butter until blended. Add to flour mixture; stir just until moistened (do not overmix). Drop by rounded tablespoonfuls onto a parchment-lined baking sheet; set aside.

Remove chicken from stockpot; cool slightly. Discard bay leaves and skim fat from soup. Remove skin and bones from chicken and discard. Using 2 forks, coarsely shred meat into 1- to 1-1/2-in. pieces; return to soup. Cook, covered, on high until mixture reaches a simmer.

Drop dumplings on top of simmering soup, a few at a time. Reduce heat to low; cook, covered, 15-18 minutes or until a toothpick inserted in center of dumplings comes out clean (do not lift cover while simmering). Gently stir in cream, parsley and thyme. Season with additional salt and pepper to taste.

Tips: You can use dried herbs instead of fresh. Dried herbs are more potent measure for measure, so cut down the amount by half.

To test if dumplings are done, stick a toothpick or skewer into the dumpling after the specified cook time. If the skewer comes out clean, the dumplings are done. If it comes out wet or sticky, cover and let cook a bit longer. Floating isn't as good of a gauge of doneness, so stick with a toothpick.

Overcooked dumplings will start to fall apart and disintegrate in the broth, so don't walk away from the stove. Be diligent about checking them when the cook time is nearly up.

We also heard from Ed Duhamel from Senexet Grange who also believed that the man in the photo John Dempsey and his wife.

Then we heard from George Kotowicz who too said that the man on the right is Jack (John) Dempsey who was Governor from 1961 to 1971. He thinks the photo is from when National Grange was in Connecticut in 1972.

We received an email from Sally Bowman stating the following: "I just opened my Connecticut Granger October issue, I am in Delaware, I am Delaware's State Secretary. I found myself staring at Rodney Dempsey's parents, Norman and Dorothy Dempsey. (Rodney is one of our State Ex Comm. persons.) Norman was our State Treasurer and Past State Master and might have been a National officer, long ago. I suspect they were visiting Connecticut when he and Dorothy went to National Session in Connecticut 40 + years ago. They are the couple on the left of the picture. They are both gone now. They were dairy farmers in the northern part of DE. Norman was State Master 1968 - 1972 and he passed in 2008. Thanks for the nice surprise!"

The Spotted Lanternfly

The spotted lanternfly, an invasive insect originally from parts of China, India, Vietnam and Taiwan, has made a re-appearance in Connecticut, posing a threat to local crops and forests and particularly harmful to apples and grapes. The brightly colored insects are about an inch long, half an inch wide with large wings. The lower wings are red with black dots and the abdomen is yellow with black bands.



transport of items that could harbor the fly, including firewood, lawn mowers, outdoor furniture, trucks and RVs in November 2014.

The spotted lanternfly was first detected in the United States northwest of Philadelphia, Pennsylvania in September 2014 when it was confirmed by the PA. Dept. of Agriculture. Based on its host affinity, it was a threat to the State's grapes, fruit trees and logging industries. They saw the greatest risk of spreading by people transporting materials that may contain egg masses laid on smooth bark, stone and other vertical surfaces. The Pa. Dept. of Agriculture issued a ban on the

States including Connecticut, Maryland, Delaware, New Jersey, New York, Virginia and West Virginia have all seen the entrance of the spotted Lanternfly. In Feb 2019, the Delaware Dept. of Agriculture signed emergency regulations enacting quarantine for this pest. There is great potential for this insect to infect almost all of the eastern part of the country.

The damage to trees and plants comes from the feeding on the sap from the trunk or branch. As it feeds the tree weeps sap which then attracts bees, ants, hornets and

paper wasps which fosters a mold which could eventually result in the death of the tree. The favorite host tree is the Asian Ailanthus also known as the tree of heaven. It is recommended that local residents cut down this tree. As early as July the adults will mate and lay eggs from late September to the onset of winter. Kill eggs from October through May by scrapping them off of surfaces. Double bag them, or put in a zip lock bag and add alcohol or hand sanitizer to kill them. Infested trees should be treated with systemic pesticides from June to August. Tree injection and bark sprays should be applied by professional applicators that may use a soil drench and foliage spray. Homeowners can apply brown sticky traps at the base of the trunk to trap the young insects.

There seems to be no major damage so far in our state, but the Ct. Dept. of Agriculture feels there is potential for great harm to the states agri-business.

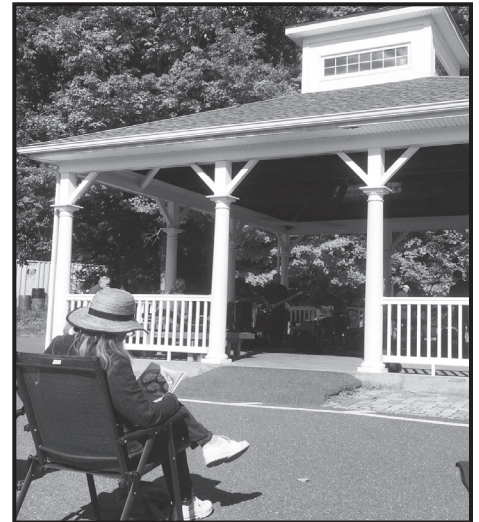

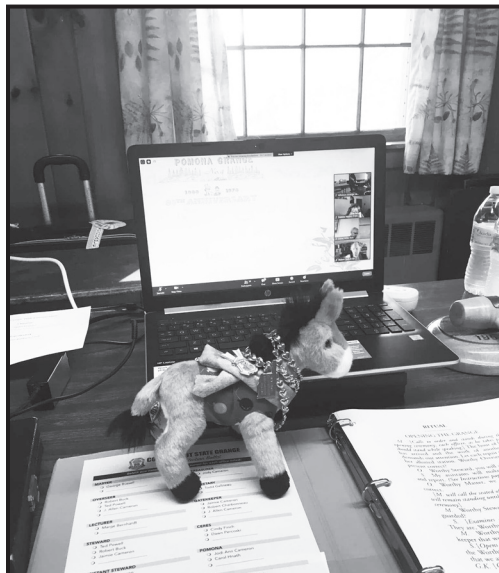

The Legislative committee met in January to review the Connecticut State Grange Legislative Policy Handbook and added any new resolutions pertaining to state and national issues to it. In early February Gordon Gibson and I went to Hartford to deliver copies of this guide to all Connecticut General Assembly members as well as the Governor and Lt. Governor.

This year Susan Masino offered to step in as our Legislative Liaison to the General Assembly with Gordon Gibson assisting her. We had just started following proposed bills of interest and had sent in a letter of support to the Environmental Committee for one bill when all things came to a complete halt. All public hearings and all legislative events were cancelled. The Capitol was closed and all legislative activity and sessions were halted. This included the annual Agriculture Day at the Capitol in which the State Grange Agricultural Committee along with the Legislative Committee always participated in by manning a Grange booth.

Since the emergence of the pandemic and the state shutdown, the Connecticut General Assembly has only held a couple of special sessions. They were called into

session by the Governor to address specific issues that were needed, mostly due to the COVID-19 pandemic.

Gordon Gibson continued his involvement with the Working Land

Alliance even as their activities were also reduced. The Grange is a partner with this organization.

Hopefully next year the General Assembly will be back running the state as it should.

My November column usually has some sort of Thanksgiving theme, and this one is no different, except for the emphasis on giving. Early on, God commanded Moses that the Israelites should not only thank God for his blessings upon them but that words of thanks should be accompanied by a sacrificial Thank Offering. Note that this should be a Sacrifice of Thanksgiving, meaning that when we give we should be giving enough of something that it becomes an act of sacrifice on our part. As an extreme example of what is definitely NOT an act of sacrifice, imagine that we have a bumper crop of Zucchini, more than we can possibly eat, and we take the surplus down to the local soup kitchen. While this is certainly a good thing to do, it is NOT an act of sacrifice on our part to do so. Giving of one's abundance is something that God expects us to do, but we get no grace points for

it; we have merely done our duty. However, if the soup kitchen in the above example is in the next Town, and you have had to give up watching a favorite show in order to find time to make the delivery, then you have sacrificed something to make your offering.

Mother Teresa once said: "This is the meaning of true love, to give until it hurts – with a smile." This should remind us of what St. Paul tells us in his second letter to the Corinthians: "Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver". So, one should give until one feels the pain of sacrifice, but one should at the same time be cheerful about it, because in reality it is only then that we know we have truly given thanks to God by giving to others. Let us all offer sacrifices of thanksgiving, and tell of God's works with joyful singing.

Wishing every one of my readers a truly joyful Thanksgiving.
